



This agreement is between Ellexus Ltd and you the customer or Software user (the Licensee).

Terms and Conditions

1. Definitions

1.1. "Software" means the software program(s) supplied by Ellexus (online or otherwise) and any related documentation, instructions, and reference materials, and Updates.

1.2. "Updates" means maintenance releases, additions, and modifications of the Software incorporating such additions and modifications which are made available to Licensee as part of maintenance services.

2. Licenses

2.1. Software License. Ellexus hereby grants Licensee a non-exclusive, non-transferable license to use the Software on a worldwide basis subject to the limitations in this agreement and the license scope.

2.2. Limitations on License. Licensee agrees that it will not: (a) disassemble, decompile, or reverse engineer (except in European Union countries, to the extent allowed by law) the Software; (b) attempt to access/use portions of the program code for which Licensee has not acquired a license, or (c) except as specifically authorized herein, distribute or transfer the Software.

2.3 License scope. The scope of the license may be further defined in the applicable Order Schedule. Some Software requires a license key. A key may be granted by Ellexus for evaluation purposes or following payment at their sole discretion. If a license key is required by the Software and not supplied then Licensee must not use that Software product for any purpose. If the license key is time limited, Licensee must cease to use the Software once the key has expired.

3. Ownership

This Agreement does not convey any rights of ownership in the Software. All right, title, and interest in the Software and in any ideas, know-how, and programs which are developed by Ellexus in the course of providing any technical services, including any enhancements or modifications made to the Software, shall at all times remain the property of Ellexus or its licensor. Licensee will retain all right, title, and interest in and to the Licensee Products. Licensee will not remove Ellexus's or its licensor's proprietary rights notices from any copies of the Software it uses, including archival and back-up copies.

4. Confidentiality

4.1. Non-disclosure. Each party may have access to confidential information of the other party ("Confidential Information"), during the term of this Agreement. Each party agrees that it will not use or disclose to any third party any Confidential Information except as permitted by this Agreement or as authorized by the other party's prior written consent. In no event will either party use less care to maintain the Confidential Information of the other party than it uses to maintain the confidentiality of its own non-public information of equal importance.

4.2. "Confidential Information" means non-public information designated in writing as confidential by the owning party. Confidential Information may include (but is not limited to) business methods, business plans, concepts, and test results, including the results of any evaluation of the Software.

Confidential Information does not include information that: (a) is or becomes publicly available through no act or omission of the other party; (b) is disclosed to a third party by the owning party without restrictions on disclosure; (c) is rightfully acquired by the recipient from a third party; (d) is independently developed; or (e) is previously known to the recipient without non-disclosure obligations.

4.3. Survival of Obligation. The non-disclosure obligations set forth in this Section will survive the expiration or termination of this Agreement.

4.4. Verification. On Ellexus's reasonable request, Licensee will furnish Ellexus with a signed statement confirming whether the Software is being used by Licensee in accordance with this Agreement.

5. Charges and Payments

Ellexus may grant Licenses free of charge for evaluation purposes or as free components of a larger product. For products that are not provided free of charge, an Order Schedule will be supplied.



6. Maintenance and Support Services

Unless otherwise specified on an Order Schedule, Licensee may purchase maintenance and support services ("Support/Update Services") on an optional basis.

Support/Update Services include email assistance on the use of the Software during normal business hours. Consultation on training and customization is available separately.

7. Warranty and Disclaimer of Warranties

7.1. Disclaimer of Warranties. THE WARRANTIES SET FORTH IN THIS AGREEMENT ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE SOFTWARE AND ANY SERVICES PROVIDED HEREUNDER. ELLEXUS SPECIFICALLY DISCLAIMS ANY WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

8. Indemnity

In the UK, under the Unfair Contract Terms Act 1977 s4, the Licensee cannot be made to unreasonably indemnify Ellexus for their breach of contract or negligence.

9. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY LAW ELLEXUS LTD EXCLUDES ALL LIABILITY TO THE LICENSEE FOR ANY LOSS OR DAMAGE HOWSOEVER ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT, INCLUDING BUT NOT LIMITED TO ANY LIABILITY ARISING IN RELATION TO THE PRODUCT.

9.1. Limitation of Liability. NEITHER PARTY SHALL BE LIABLE TO THE OTHER PARTY OR TO ANY THIRD PARTY FOR ANY SPECIAL, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, WHETHER SUCH DAMAGES ARISE UNDER A TORT, CONTRACT, OR OTHER CLAIM, OR DAMAGES TO SYSTEMS, DATA, OR PROGRAMS, EVEN IF SUCH PARTY HAS BEEN INFORMED OF THE POSSIBILITY OF SUCH DAMAGES. In no case will Ellexus's liability for damages hereunder exceed the license fees paid to Ellexus by Licensee under this Agreement. With respect to any annual license, Ellexus's liability will be limited to the fees paid to Ellexus by Licensee during the most recent twelve (12) month period.

10. Term and Termination

10.1. Term. This Agreement will take effect as soon as the Licensee downloads or uses the Software.

10.2. Termination. Ellexus or Licensee may terminate this Agreement or any license at any time.

10.3. Effect of Termination. Except as otherwise provided herein, upon the effective date of any license termination, Licensee shall cease using the Software provided under such license.

10.4. Survival of Obligations. The following obligations will survive termination of this Agreement for any reason: (a) obligations relating to non-disclosure of confidential information; (b) obligations relating to indemnification; (c) obligations to make payments of amounts that become due under this Agreement prior to termination.

11. General Terms

11.1. Governing Law. This Agreement shall be governed by, construed and take effect in accordance with English law and the English courts shall have exclusive jurisdiction to settle any claim or dispute which may arise out of or in connection with this Agreement.

11.5. Dispute Resolution. Any claim, dispute, or controversy ("Claim") arising out of this Agreement will be discussed by the parties, escalating as necessary to the top management of each party.

11.6. Severability. In the event that any provision of this Agreement is found to be invalid or unenforceable, it will be enforced to the extent permissible and the remainder of this Agreement shall remain in full force and effect.
